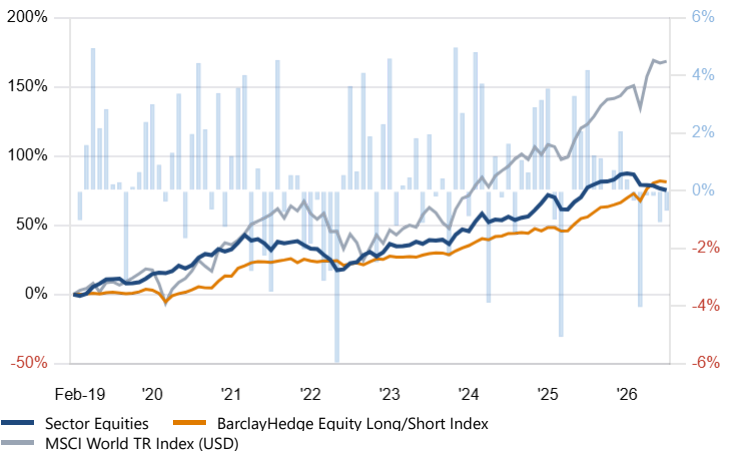

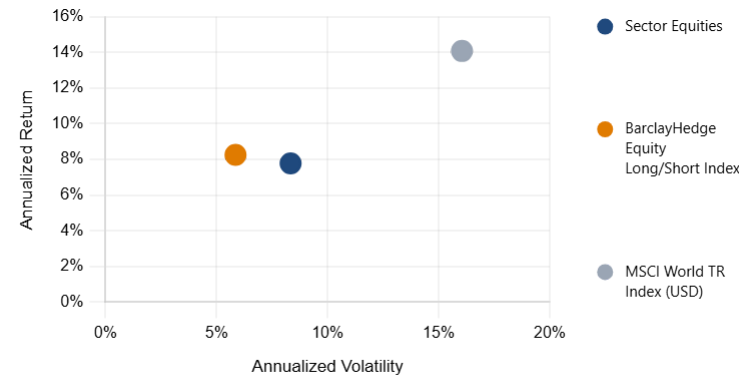
CUMULATIVE RETURNS SINCE INCEPTION



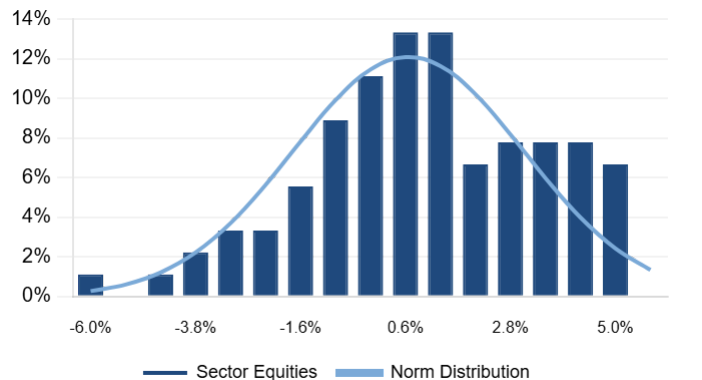
