Strategy description

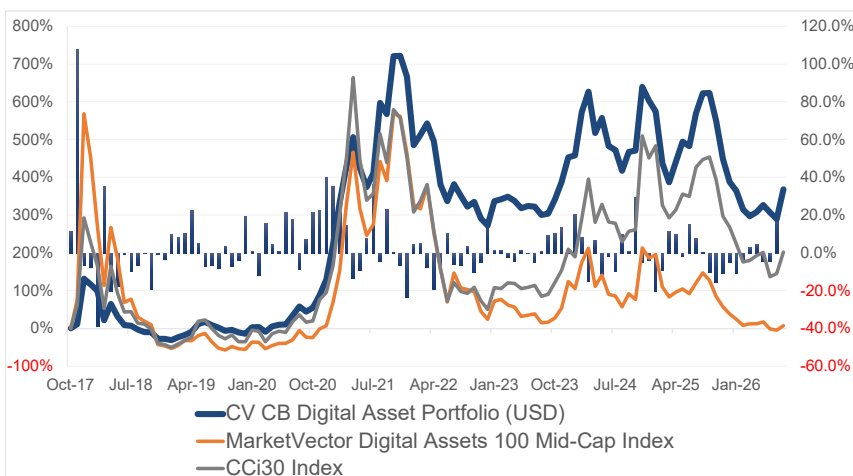
The CV CB Digital Asset Portfolio seeks to generate strong, uncorrelated returns by capitalizing on the long-term growth opportunities created by digital asset ecosystems. To achieve this goal, the certificate invests in actively managed, digital asset dedicated hedge funds that deploy discretionary or systematic strategies. Positions taken by these funds will range from long only, venture-style investments to relative value and market neutral positions across a wide range of digital tokens or crypto currencies. The certificate is diversified across sub-sectors, investment strategies, trading styles and time horizons. Investors can subscribe to the certificate at month-end with 1 day notice and redeem from the certificate with 45 days' notice.

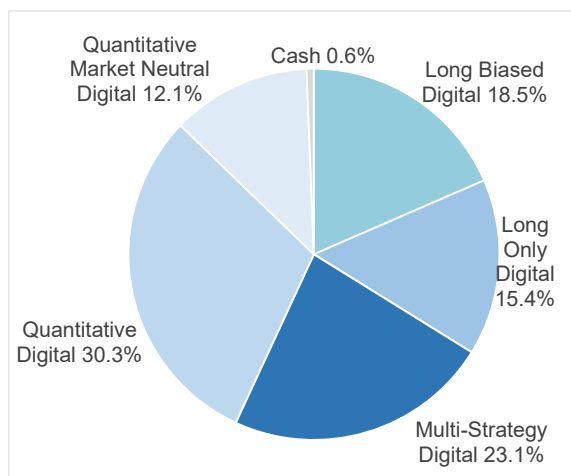

Cumulative returns since November 2017



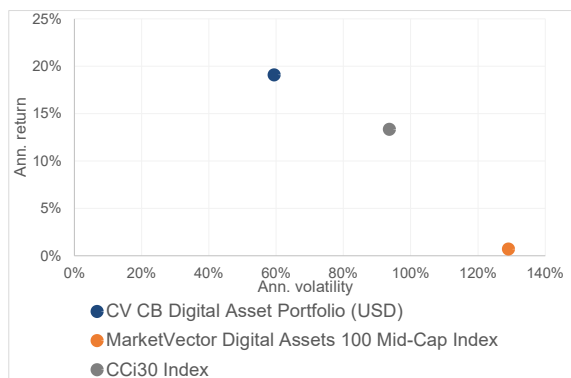

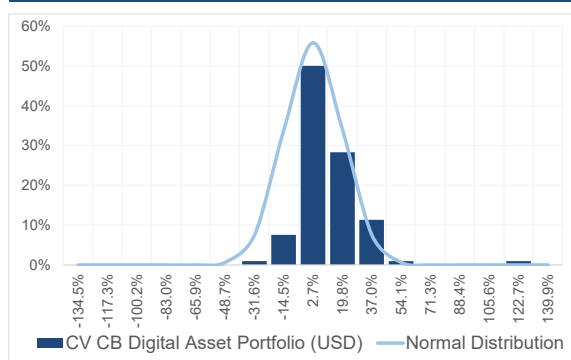
Risk vs. return since November 2017
