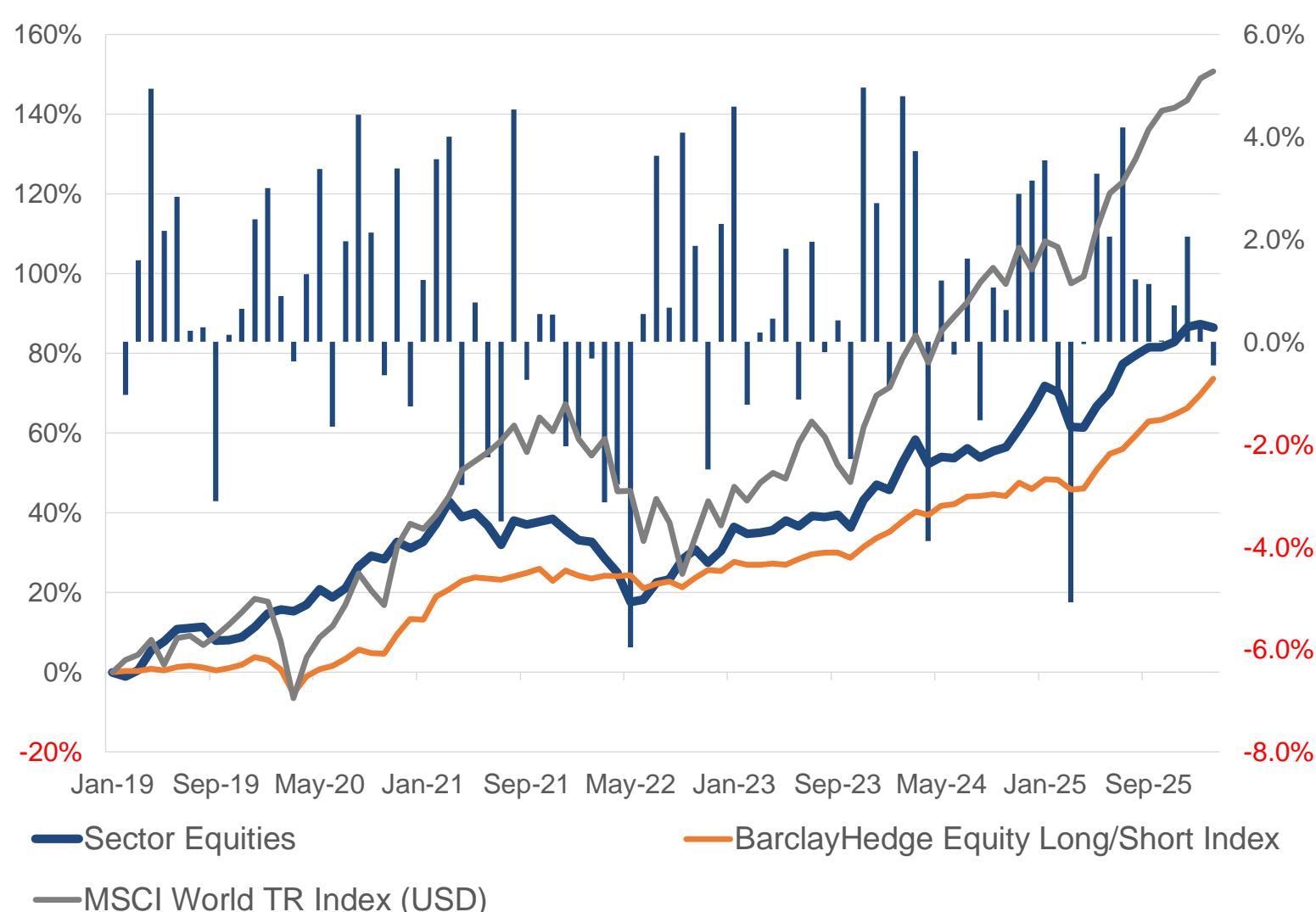

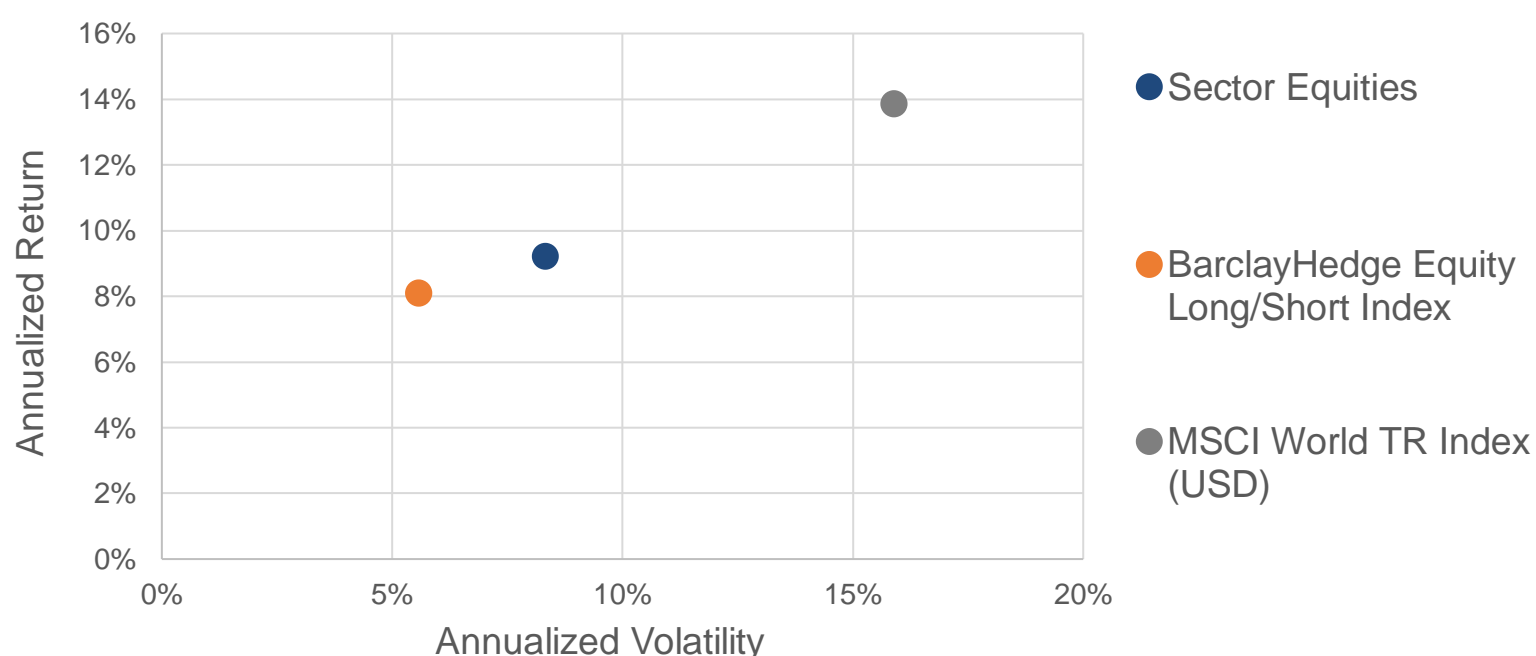
Cumulative returns since inception



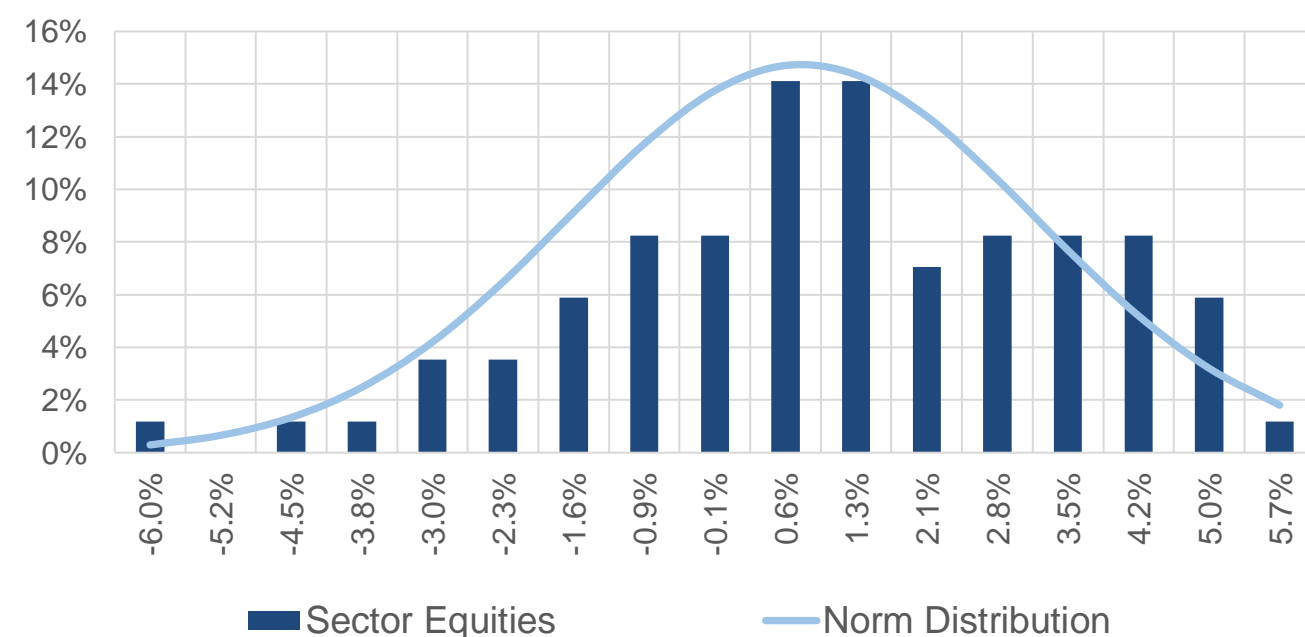
